一、校基本要求：

1. 本校四技日間部實施1+3畢業條件，係指學生畢業時應具備1張畢業證書及3張相關證照，3張相關證照得以下列兩種方式擇一取得：
(1) 通過A類語文證照及2張B類證照。
(2) 通過A類語文證照及1張C類證照。
2. 本系證照認定請參照「應日系四技日間部畢業條件標準表」。

二、系基本要求：

1. 畢業學分數為130學分(含校訂必修36學分、院核心必修12學分、系訂必修64學分，選修至少須達18學分)。
2. 每學期修習學分數：不得多於32學分，不得少於10學分；惟當學年度應屆畢業生，每學期不得少於5學分；校外實習學期為10學分。
3. 校外實習成績需根據廠商實習證明並檢附該實習成果，作為成績評定標準。
4. 跨系選修學分數(含跨領域微學分學程及各類學程課程)不得超過4學分。
5. 各年級不得修習本系以外之日語相關課程。
6. 4年級生經本系認可得修習跨校重補修課程。

三、就業課程模組規範：

1. 本系設置有「餐飲暨旅館服務模組」與「旅運服務模組」兩大課程模組。
2. 本系學生於畢業前至少應修畢其中一個課程模組，各模組之課程內容及修課相關規定詳見附件。

四、其他說明

School Basic Requirements:

1. Our school's four-year college program, follows the 1+3 graduation requirements. This means that upon graduation, students should possess one graduation certificate and three relevant licenses. The three related licenses can be obtained through either of the following two methods.
(1)Achieving A-level language certification and two B-level certifications.
(2)Achieving A-level language certification and one C-level certifications.

2. For certification recognition in our department, please refer to the "Requirements for Graduation of Four-Year College Program in Applied Japanese Department."

Department Basic Requirements:

1. The required credits for the degree are 130 credits, including 36 required GE credits, 12 college required credits, department required 64 credits and 18 elective subject credits.
2. The credit requirements for each semester are as follows: a minimum of 10 credits and a maximum of 32 credits. However, for new graduates in the current academic year, a minimum of 5 credits is required per semester. The external internship semester carries a credit value of 10 credits.
3. The grading of the Off-campus Internship is partially based on the certificate of internship referred by the company and the internship reports/assignments.
4. The number of elective credits for cross-departmental courses (including credit programs) must not exceed 4 credits.
5. Students in each grade level are not allowed to take Japanese-related courses outside of our department.
6. Senior students, with approval from our department, may take cross-school remedial courses.

Employment Course Module Regulations:

1. Our department offers two major course modules: "Catering and Hotel Services Module" and "Travel Services Module."
2. Before graduation, students in our department are required to complete at least one of the course modules, with detailed information about the content and relevant regulations for each module are available in the attached document.

Additional Information:

1. Adjustments to the number of classes in representative general education courses may affect the scheduling of course semesters.
